Exhibiting Terms and Condition:

1. **Application Procedure:** Participation is finalized only after the exhibitor submits a completed application form and all relevant documents, and pays the booth fees through to the organizer Worldex G.E.C. Co.,Ltd.. Booth allocation rights are granted only after the organizer approves the application. Failure to pay in full within the designated timeframe grants the organizer final authority over booth allocation.
2. **Costs:** Exhibiting Fee covers venue rental and booth fascia and basic set-up (except for exhibitions where the fee excludes decoration). All other expenses must be borne by the exhibitor.
3. **Our Responsibilities:** Our companies are responsible for:
 - a. Assist the organizer in liaising the exhibition venue, decoration, and booth allocation.
 - b. Supporting post-exhibition and related administrative matters.
 - c. Providing basic on-site services.
 - d. Providing exhibition-related consulting services.
4. **Exhibitor Responsibilities:** Exhibitors must:
 - a. Provide exhibits and assign personnel to attend. Exhibitors bear full ownership responsibility for their products and must not infringe upon domestic or international patents or intellectual property rights. Any consequences of such infringements are the sole responsibility of the exhibitor.
 - b. Not transfer, sublease, or lend the booth to any company outside of our official delegation.
 - c. Settle all miscellaneous expenses incurred on-site.
 - d. Adhere to the organizer’s rules and refrain from actions that harm the interests of other exhibitors or national reputation.
 - e. Not damage or alter the booth’s design, decoration, color, or materials without permission.
5. **Force Majeure and Liability:** The decision to participate rests with the exhibitor. If the exhibition is cancelled, postponed, or undergoes changes (including scale or effectiveness), our companies shall not be held liable for any secondary or compensatory damages.
6. **Third-Party Services:** Our companies may recommend logistics providers, contractors, or travel agencies. While we will exercise due diligence as a responsible manager, we are not liable for any accidents or unforeseen circumstances arising from these services.
7. **Site Restoration:** Exhibitors must remove all personal items and decorations (excluding the official booth structure) after the event. Any cleaning or removal fees incurred by the organizer due to leftover items will be charged to the exhibitor.
8. **Withdrawal Policy:** If an exhibitor withdraws after registration and payment, the booth fee will not be refunded in full.
9. **Special Declaration Regarding Intellectual Property:** Our Companies focuses solely on providing the aforementioned exhibition services. Any legal issues involving intellectual property or infringement related to the exhibitor or their products are the sole responsibility of the exhibitor. This includes handling and bearing the costs of any seizures, lawsuits, or actions taken by rights holders or local courts.
10. **Final Authority:** The organizing unit reserves the right to modify, change, and provide the final interpretation of these regulations.
